Lee enjoys contesting on CW during CWT's (weekly CW Operators one hour contests on Wednesdays).



LARK ByLaws Update - Proposal Jan 2023



BYLAWS OF THE LIVERMORE AMATEUR RADIO KLUB

ARTIC LE I NAME

The name of this organization shall be the Livermore Amateur Radio Klub, and will also be properly known as LARK. LARK is a Non-Profit Organization under the laws of the State of California Articles of Incorporation.

ARTICL E II Purpose

Consistent with the Articles of Incorporation, this Corporation is formed to engage in any lawful public tax-exempt not-for-profit business purpose as defined by U.S. Internal Revenue Code 501(C)(3).

This includes delivering educational content related to Amateur Radio (described in Part 97 of C.F.R. 47), hands-on training experiences, license testing online and in-person at regularly scheduled meetings.

The organization also provides communications and logistical support to other non-profit organizations and government agencies.

ARTICLE III Members hip

Section 1. Membership in LARK shall be available without restriction based on age, sex, religion, or national origin.

Section 2. There shall be three classes of membership:

Full Members shall be those persons holding a valid Amateur Radio license issued by the United States Federal Communications Commission or legal aliens with valid Reciprocal Operating Privileges.

Associate Members shall be all other persons wishing to join LARK who do not hold a valid Amateur license or Operating Privileges. An Associate Member shall

in Article IV.

Event Members shall be those persons volunteering and supporting the organization for a pre-defined period of time or named event. Membership is limited to the time that the individual is assisting the organization in any role.

Section 3. Initiation Fee and Dues will be set by the Board of Directors. Any member who is more than three (3) months in arrears on dues may be removed from the active roster of members.

Section 4. The Board of Directors may, at its discretion, award a Life Membership to any member (Full or Associate) who has displayed outstanding effort or service to LARK or its programs for a significant period of time. No more than Two (2) Life Memberships may be awarded in any calendar year, and there is no requirement to issue a life Membership in any given year.

Section 5. In the unusual case of a member who brings dishonor on LARK because of serious violation of FCC Regulations or Civil or Criminal Law, the member may be expelled from membership by a three-quarters vote of the Board of Directors. The person involved shall be notified immediately by the Secretary of such action, and the dues for the year in question shall be immediately refunded in full. Such a person may be reinstated to LARK membership only by a two-thirds vote of the Board of Directors.

ARTICLE IV Officers

Section 1. Board of Directors. The Officers of LARK shall be: President, Vice-President, Secretary, Treasurer, Activities Chairman, and three (3) Directors. These eight (8) persons make up the Board of Directors. The officers shall serve without compensation, but may be reimbursed for ordinary and reasonable expenses incurred in the performance of their duties.

Section 2. Elections. Election of Officers shall be held at the April Meeting unless changed due to extenuating circumstances, and officers shall take office on the First day of the following month after the election. Officers are elected for a one-year term. Election shall be by acclamation if there is only one candidate for each of the offices and board members. If there are more than one candidate for any office, election shall be by secret ballot of Members in attendance. A majority shall be required to be declared winner. In the event that no candidate receives a majority, an immediate run-off shall be held between the two candidates who received the most votes.

Section 3. Eligibility for Office. All officers, at the time of election shall be Full Members of LARK. The President, Vice-President, Secretary, Treasurer, Activities Chairman, and Directors must be Full Members of LARK, and have a current Ham License and a member of LARK for at least six (6) months.

Section 4. Directors. There shall be three (3) elected members of the Board of Directors; at least one of the Directors should be a Past President and designated as such.

Section 5. Nominating Committee. A Nominating Committee appointed by the Board of Directors shall present a list of candidates for all offices up for election, preferably with at least two candidates for each office and three candidates for the two elected Directors. The candidates shall be announced at the regular March meeting, if possible, and must be printed in the LARK Newsletter preceding the April election. Nominations from the floor are permitted with the approval of the person nominated.

Section 6. Duties of Officers.

President – Shall preside at all LARK meetings, represent LARK as necessary, and perform the duties customarily associated with the office;

Vice-President – Shall fill-in for the President as necessary and shall ensure that the Activities, in the absence of the Activities Chairman, and Publicity functions are completed as necessary;

Treasurer – Shall handle all financial affairs of LARK and shall submit to an annual audit as requested by the Board of Directors.

Secretary – Shall record the minutes of all LARK meetings, shall manage correspondence, and shall handle such other tasks as are normally associated with the position.

Activities Chairman – Shall arrange programs, speakers, field trips, activities, etc. as are appropriate;

Directors – Shall attend all LARK functions, within reason, shall participate in Board of Director activities, deliberations and discussions, and shall perform such ad hoc tasks as are appropriate.

Section 7. Removal of Officers. Any officer who, for whatever reason, ceases to be an active member of LARK shall be immediately removed as an officer. Any officer who misses four (4) consecutive Regular and Business meetings without a valid excuse can be removed at the discretion of the Board of Directors.

Section 8. Replacement of Officers. In the event of a vacancy in the Presidency, the Vice- President, shall become President; a vacancy in any other office shall be filled by appointment by the Board of Directors; a vacancy in the Past-President Director position can only be filled by another Past-President, or it may be left vacant at the discretion of the Board for a period not to exceed three (3) months.

Section 9. Recall of Officers. An officer may be recalled (removed from office) if a petition with no less than 20% of the active membership, requesting a recall vote, is presented to the Board of Directors; the officer shall be immediately removed if a 60% vote by secret ballot of Members in attendance at the next Regular Meeting

ARTICL E V Meeting s

Section 1. Regular Meetings. Regular meetings shall be held normally once per month on the Third Saturday of the month; Business meetings shall normally be held once per month at a time and place chosen by the Board of Directors and announced at least one week in advance. Regular meetings are intended to be for technical information, discussion, education, social, and similar activities, with a minimum of business transaction. The board of directors reserves the right to alter the date of the meeting or cancel it altogether for any reason.

Section 2. Business Meetings. The Board of Directors is given the authority to manage the business affairs of LARK, the primary discussion of which shall be at Business Meetings. All LARK members are welcome at Business meetings and shall have a vote at such meetings, unless specifically stated as otherwise by these Bylaws. In particular, the Board of Directors is empowered to spend/commit LARK funds up to \$1000 without approval of the general membership; proposed expenditures in excess of that amount shall be presented with an appropriate recommendation at the next Regular meeting.

Section 3. Quorum. No Quorum is required for a scheduled regular meeting. A quorum for a Business Meeting shall consist of one-half or more of the Board of Directors, as defined in Article IV, Section 1,

Section 4. Stipends for NON Member. Guest Speakers/ Invited Guests for LARK meetings or other official LARK functions may be reimbursed for their actual costs plus a reasonable gratuity decided by the Board of Directors.

ARTICLE VI Committ ees

Section 1. Standing Committees. Standing Committees shall be Newsletter, Emergency Services, Finance, Swap Meet, Repeater, and RFI. This list may be changed by action of the Board of Directors without need of normal by-laws amendment procedures.

Section 2. Other Committees shall be established, as needed, e.g., VE Team, Audit, County Fair, T-Hunt, Field Day, Special Events. All Committees shall have a point of contact identified and all committees shall report at regular intervals to the membership or Board, as appropriate.

ARTICLE VII Parliamentary

The rules contained in the current edition of the Robert's Rules of Order Newly Revised shall govern LARK in all cases in which they are applicable and in cases where they are not inconsistent with other sections of these Bylaws or any other special rules LARK may adopt.

ARTICLE VIII Amendme nts

These Bylaws may be amended by two-thirds vote of Members of the LARK in attendance at any Regular meeting, provided that the Amendment, and any modifications to the Amendment, having been presented in writing at a previous Regular Meeting.

ARTICLE IX Taking Effect of These Bylaws

These Bylaws shall take effect thirty (30) days after approval by two-thirds vote of the membership in attendance at a Regular Meeting. The vote to adopt shall take place (at least) one Regular meeting after that at which these proposed Bylaws were first presented to the membership; the proposed new Bylaws shall have been announced in the Newsletter before the meeting at which the vote to adopt is held, and all active members shall have received, or had available, a copy of the proposed new Bylaws.

ARTICLE X

Dissolution of LARK

In the event of the dissolution of LARK, cash on hand or investments shall be paid first to outstanding debtors, if any.

Any residual cash and assets such as repeaters, test equipment, etc will be donated to an appropriate 501(C)(3) organization such as Mount Diablo Amateur Radio Club.

Why use Morse Code?

- World wide contacts with very simple equipment - 100 watts & dipole antenna
- Spectrum efficient 150 Hz @ 30 wpm
- Able to copy very weak signals
- Almost all HF radios have the CW mode.
